USER CLASSIFICATION

The ESRGC and Queen Anne's County implement discount rates for different classes of data licensees. This is to help insure equitable access to the spatial data.

For profit company	No discount (requires federal tax id)
Private citizens	No discount (requires a copy of drivers license)
County contractor	No reproduction (up to 43.50) or maintenance fee (As per the licensing agreement data must be destroyed when the contract expires)
Federal, State, and Local Government	No reproduction (up to 43.50) or maintenance fee (The County is amenable to data sharing and would request that any data the soliciting agency has that would benefit the County be offered to the County for comparable fees. To share your data please contact the County GIS division at (410) 758-1255)
Non-profit company	50% discount
Educational Institution	50% discount
High volume	20% discount (Users with a total order amount over \$10,000)

SPECIAL PROCESSING (\$30/hr)

If the licensee requires special processing, please contact the ESRGC to receive a quote for the service. Examples of special processing would include: spatial clipping, reprojection (by default, all datasets are in Maryland State Plane Coordinate system, NAD 1983), and other data manipulation. The cost of these services can vary greatly depending on the extent of the requested modifications.

HOW TO ORDER:

Order forms may be found at the ESRGC website (www.esrgc.org) as well as index maps of the County's spatial data tiles. Order forms (for either image/raster data or object/vector data) must be submitted, along with a Copyright Owner License Agreement and an ESRGC Data Distribution Agreement before an order can be processed.
